

## **TI SPAIN WORK PLAN 2017**

In accordance with the objectives outlined in the Strategic Plan for TI-Spain, in 2017 (and subsequents) is planned to develop the following Plan of activities:

- Continue the development of the three fundamental axes of the *Integrity Project*: This project, with a time horizon of four years (2015-2018), aims to prevent corruption and create fair market conditions in society and in the Spanish economy.
- Contribute to improving the adequate implementation of Law on Transparency in Spain, really crucial issue for Spanish public and political life in the coming years (in collaboration with the CTBG based in our Agreement).
- Continue the activities of the *Commission on Transparency and prevention of corruption in public tender and procurement*: This Commission has been set up in order to contribute and promote the informative clarity in these proceedings, by proposing measures to prevent and hinder corruption in institutions and among representatives related to them.
- Continue the activities of the *Commission of Legal and social measures against corruption*: The purpose of this Committee is to contribute from TI-Spain to prevent and combat corruption by proposing plausible measures and practices to combat this major social problem in Spain.
- Continue the activities of the *Commission on Integrity in Financial System and Banks*: Commission for contribute to improve the transparency and integrity, and preventing the corruption in Financial System and banks.
- To promote and evaluate the transparency, integrity and internal democracy of Spanish Political parties, and the level compliance of GRECO recommendations.
- Publishing the three numbers of 2017 of *International Journal of Transparency and Integrity*: This magazine aims to be an editorial reference in Spain and internationally on issues related to transparency, integrity and combating corruption.
- Monitoring of different Agreements of Transparency and prevention of corruption.
- Monitoring and control of Transparency Portal Government. Analysis and promotion of the transparency law in its application (Integrity Project: Objective 3)
- To promote the integral implementation of 10<sup>th</sup> Principle of the UN Global Compact entitled "Fighting corruption and promoting transparency".
- To maintain and improve the methodology of Index of Transparency of Municipalities.
- To maintain and improve the Index of Transparency of Communities Autonomous.
- To maintain and improve the Index of Transparency of Parliaments.

- Establish a broad and generalized various education and training plans at different levels in relation to values social, ethical, integrity and transparency, especially in children and young people.
- Platform "*Participación ciudadana*": Platform to promote citizen participation and their relationship with TI-Spain.
- Participate actively in the "Unmask the Corrupt", promoted by Transparency International Secretariat.
- *Monthly Newsletter*: TI-Spain will continue publishing the Newsletter (three times each month), that makes possible to publish updated news, events, etc. that is developed both in Spain and in other countries in relation to transparency and the fight against corruption.
